Fuel card integration is a free service for NexTraq® customers and activation is simple for clients who currently have a CFN fuel card. When you want to add fuel card functionality, account verification through the NexTraq solution is all that is needed.

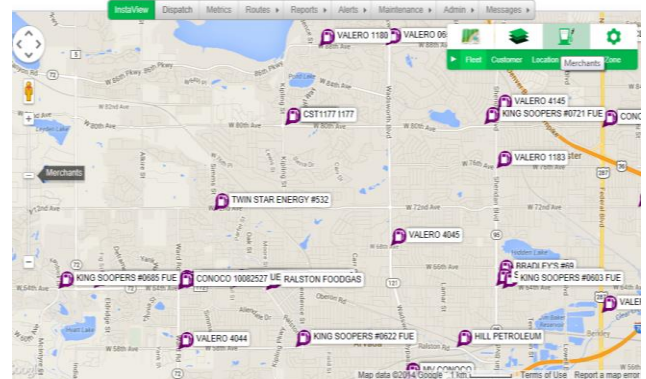
Fuel Data Integration



Companies with a CFN fuel card can incorporate gas card data and fuel card transactions into the NexTraq solution. Purchase location and date for each card transaction is GPS confirmed which allows a better understanding into its fleet's fuel utilization.

Points of Interest (POI) Mapping

All stations in the CFN fuel card network have been added to the NexTraq solution. Once a client activates an account, these stations can be seen on the InstaView tab. Users can identify these stations and easily direct drivers to the closest location.



Reporting

NexTraq's Fuel Card Purchase History Report provides a full summary of all fuel and fuel related purchases. It shows in-depth purchase details by company, fleet and/or mobile, streamlining the retrieval of fuel card data. The Fuel Tax IFTA Report is for OTR companies who have to submit Fuel Tax reports and greatly simplifies their reporting process.
